Thank you for applying to Water's Edge Art Festival. This event will be judged, meaning that a committee will review your application and your work to determine acceptance. We do this because we want the Water's Edge Art Festival to be a high-quality event, and differentiate it from the typical craft or flea-market style shows. You will be judged on the category that you have indicated on your application. All decisions made by the committee are final and there are no exceptions.

## Artist Terms and Conditions

- Artists will be charged a \$50 fee for any NSF "bounced" check(s), and be required to submit a money order to cover the entry fee and/or booth fees affected. NSF fees not paid within one week of notification, will result in rejection from the event.
- Outdoor booth space is limited to an 11-square-foot area. Indoor covered booth space is limited to an 8-square-foot area. Artists with large displays can purchase multiple adjacent booths to display their artwork, etc. Artists may not go beyond their designated booth space.
- Once an Artist is accepted, entry fees and booth fees are non- refundable. No exceptions.
- Artists will be notified of their acceptance upon conclusion of the meeting of the committee on/by April 8, 2018. An additional email with information identifying the Artist's booth location, setup time, and any other instructions will follow one month prior to the day of the show.
- Artists will not be allowed to switch booth locations the day of the event, even if there are Artist no-shows or open spaces.
- The Artists can only sell artwork within the same category that was entered on their application form. Work must be of original concept, design, and execution - no kits, moldwear, work produced from commercial patterns, or manufactured pieces will be accepted.
- There are no guarantees on the amount of sales any Artist will make.
- The Artist agrees not to cause any problems with fellow Artists or Water's Edge Committee members or Wiegand's Lake Park staff. Artists should notify a Water's Edge Committee member about any issue with another Artist, and the Committee will investigate and take the appropriate action.
- Booth sitters or unloading/setup assistance will not be provided by Water's Edge Art Festival, so plan on bringing assistants.
- Exhibits must remain open and attended by the Artist for the duration of the show, on both days, Saturday and Sunday 10 a.m.-5 p.m. Do not pack up early.
- As a service to you, your contact information may be given to prospective customers who visited the show and wish to make a purchase afterwards.
- All sales will be handled by the Artist and individuals are responsible for their own tax collection and payment. Please note that Novelty is in Geauga County for tax purposes. (6.75% Tax Rate)
